Basic Info:

All 32 teams will be divided into brackets of 4 teams each. For each bracket there will be a round robin and all teams will play each other – 3 matches total. Based on the results of the bracket play teams will advance to either a Gold, Silver, Bronze, or Copper Draw. Within each draw will be an additional 3 matches, win or lose. There will be 6 matches total for every team at this event based on the expected 32 total teams.

1st and 2nd place teams from the Gold bracket of this tournament will receive automatic bids to the 2012 Tennis on Campus National Championship.

Each school may enter up to two teams. Each team can consist of up to (5) males and (5) females. A minimum of (2) males and (2) females are required per team.

Entry Fees:

\$175.00 per Team. Fee is non-refundable after October 1st.

Entry Deadline:

The entry deadline is October 1st. Entries will be taken on a first-come first-serve basis after that date if there is still space available. After October 1st the entry fee raises to \$200 per team.

Team Expenses:

Each college/team will be expected to pay for all expenses incurred by the school. **Recommended lodging** is hosted at the [Hilton Head Marriott Resort and Spa](#), but each team is responsible for making their own reservations and for the cost of hotel stay.
